You can contact the police department in several different ways:

1) Dial 911 for immediate assistance.

2) Dial 843-743-7200 to report anonymous information directly to the police operator.3) Text 911 (See instructions)

4) Dial 843-722-0558 to leave a message on the Housing Authority Crime Hotline.

All apartments are equipped with telephone jacks. If you plug in any telephone, you may be able to dial 911. This is a very important free resource for your safety. Should your jack be inoperable, please call Director Wright for further information.

You are responsible for the persons on your lease and your guests or visitors. Therefore, it is very important that you advise your children and visitors to abide by the lease accordingly. You must also keep all guests or visitors with you and at your unit. Guests and visitors have no rights or privileges to Charleston Housing Authority Property. Familiarize yourself with the banned persons list. Be knowledgeable of the fact that this list does not eliminate the responsibility you have to keep other criminals and active participants from your apartment and the properties of the CHA.

You should become active in your resident association. Your participation is important and will keep you infom1ed of your area's issues, problems, and concerns. You should become aware of the many worthwhile programs and resources of your Programs Specialist on your respective Management Team. Take advantage of the help

RULES REGARDING UNAUTHORIZED PERSONS IN ORDER TO AVOID EVICTION/LEASE TER.I\!IINATION

- Unauthorized persons includes unauthorized live-in(s) residing in the unit more than fourteen (14) days and can include guests, visitors and other persons under the tenant's control that engages in activity that violates the dwelling lease or program. A person under the tenant's control is an individual given express or implied permission by the resident to have access to the unit or premises.
- If a resident has an unauthorized person residing in the unit who is not listed on the lease, he/she must ask them to leave immediately. The resident shall not allow persons other than those listed on the lease and minor children which are born into the household during- this tenancy, to reside in the dwelling unit for more than fourteen (14) days each without obtaining prior written approval of the landlord. An unauthorized person found to be residing in the unit is a lease violation and may result in termination of lease. (Applicable to public housing nly) All other program participants must adhere to the lease provided by their landlord.

• The resident shall use the premises as a dwelling for himself or herself and persons named in the lease only, with the exception of minor children born into the household during the tenancy.

- Any additions or changes to the household listed on the lease require written advance approval of the Landlord. This includes Live-in Aides, Department of Social Services (DSS) actions, and foster children or adults, but excludes natural births.
- The Landlord may approve the additions or changes if they pass screening and the appropriate size unit is available.
- The resident/participant shall not sublet the unit, or any part of the unit. The unit is for the resident only and those placed on the lease by the resident. Subletting all or any part of the unit is a lease violation and may result in termination of lease.
- Removal of persons from the household shall be reported to the Landlord in writing, within ten (10) days.

Resident Initials



- The resident/participant shall not allow an unauthorized person (livein, guest, visitor or other persons under the tenant's control) who participates in violent, drug-related ccriminal activity or is listed in the South Carolina Sex Offender Registry to have access to the unit. All household members listed may be subject to lease termination in the event that any unauthorized person participates in a violent or drug-related criminal activity or is a registered sex offender, whether or not the resident had actual involvement or knowledge of the violent or drug-related criminal activity.
- CHA will make a determination of lease termination based upon a number of factors, including but not limited to, the seriousness of offending action(s), resident's degree of culpability, any and all health and safety concerns of other residents, employees, and the surrounding community, and tenancy history of the resident.
- All individuals listed on the Prohibited Persons list are considered an "unauthorized person". However, the absence of an individual's name does not mean they are authorized or unauthorized. The prohibition is based on background and criminal history. All residents have received a copy of the list and can find an updated list on the CHA website at <u>www.chacity.org.</u>

CHANGE OF ADDRESS FOR IDENTIFICATION ADVISORY

SECTION 56-1-230. Notification of change of address or name. [SC ST SEC 56-1-230)

"Whenever any person after applying for or receiving a driver's license shall move permanently from the address named in such application or in the license issued to him or when the name of a licensee is changed by marriage or otherwise, such person shall within ten days thereafter notify the Department of Motor Vehicles in writing of his old and new address or of such former and new name and of the number of any license then held by him.¹¹

In accordance with above applicable quoted law, please change your address on your license or/and identification card at the SC Department of Motor Vehicles Office. Also make sure, your license has your name spelt correctly and if not notify the OMV accordingly. There is no charge at the SC OMV Office for this change unless you voluntarily elect to get a new card.

After you do so, bring a copy of the receipt verifying the change or new card (within two weeks pf below date) to the management office so we may update your file.



When should I text 9-1-1?

You should only text 9-1-1 if making a voice call is not possible. Text-to-911 is useful to those who are hard of hearing, deaf, or speech-impaired.

Text-to-911 could also help in situations when a caller is facing a threatening situation and a voice call could increase the threat; the caller is injured and cannot speak; the caller is in a remote location and can only send out a text message; the phone battery is low; or other scenarios.

When should I t1se 911J1elpmeecorr1?

You should only use 911helpme.com if you cannot make a voice call or text 9-1-1. If the 9-1-1 lines in Charleston County are ever down or jammed, you can report your emergency on 911helpme.com. If you do not have access to a phone, but have a tablet or computer with internet access, you can report your emergency on 911helpme.com

911helpme.com can also help if we have a severe weather event in Charleston County that knocks out the 9-1-1 phone lines; if there is any large-scale event and the

9-1-1 lines are jammed; if you lose your phone during an incident but still have your tablet/computer; or other scenarios

How does it work?

Text-to-9-1-1

- .. Open a new text message.
- ^a Place 911 in the recipient field.
- Your first message should be brief and include location & nature of the emergency.
- Send the message.
- Be prepared to answer questions and follow instructions from the 9-1-1 call taker that will text back.
- Text in plain language. Do not use slang, abbreviations, emojis, pictures or video.
- " Once you have initiated a text-to-911 conversation, do not delete the messages or turn off your device until the call taker tells you it is okay to do so.

- The site will automatically ask if you are at an address. If this address is correct, click "YES." If not click "NO."
- Continue filling out the information about your emergency as prompted by the website.
- The address and nature of the emergency are both necessary for responders to be dispatched.
- Do not use slang, abbreviations, emojis or video. Use plain language
- You must click the reCAPTCHA box, proving that you are not a robot.
- After all information you need to report to 9-1-1 is entered, click the blue "Save and Submit" button on the bottom left of the page. This information is immediately sent to a 9-1-1 call taker and responders are then dispatched.
- 911helpme.com is only available in Charleston County and sends information to Charleston County Consolidated 9-1-1 Center.

- If you call 9-1-1 by mistake, do not hang up. Wait for the Call Taker to answer and then explain to the Call Taker that you dialed 9-1-1 by mistake.
- Do not hang up until directed to do so by the Call Taker.
- Remember, answering the Call Taker's questions does not slow down the response to your emergency.

When Should i Cail 9-1-1?

Call 9-1-1 to Save a Life, Stop a Crime or Report a Fire.

You should call 9-1-1 even if you are not certain if your situation is an emergency. It is always better to be cautious.

What Happens When I Call 9-1-1?

The Call Taker will start the conversation by requesting the following information.

- What is the address of your emergency?
- Tell me exactly what happened.

As soon as you let the Call Taker know your exact location and what the emergency is, the information is sent to the dispatcher who will be sending help while you continue to answer the Call Taker's questions. This will allow you to get the best help as soon as possible and does not delay a response by emergency services.

You need to remember that the Call Taker can't see you or what you see. If the Call Taker asks you to do something that you think is unsafe or makes you feel uncomfortable, you should tell the Call Taker that.

When Should I Send a Text-To-9-1-1?

Text 9-1-1 only if you cannot make a voice call.

Some examples: Home invasion, domestic disturbance, or kidnapping. Texting 9-1-1 is not as quick as calling, but can be useful when a voice call is not an option.

- If you are in an area where Text-to-9-1-1 is not available, you will receive an automatic message letting you know that you need to make a voice call to 9-1-1.
 - Don't text or use devices & drive.
- Text simple, short messages. No slang, abbreviations, emolis, pictures or videos.
- Include your location and nature of the emergencyy in the first message.
- Answer the Call Taker's questions to the best of your ability.


When Should | Use 911 helpme.com?

911helpme.com should be used if you can't call or text.

Some examples: Burglary where someone stole Your Phone but not computer, you only have a tablet with data that can't call or text, your phone is not working with text or voice.

- Search 911 helpme.com
- Enter the address of the emergencyy and any details into the appropriate fields.
- Accept the CAPTCHA "I am not a robot" field and submit your report.

For active seniors, a Safety Profile can provide peace of mind that in the event of an emergency 9-i -1 would have details on their home and medical needs. For caretakers, they can be assured that if the person they care for needs to dial 9-i-i when they are alone, their details are available and the caretaker can be listed as an emergency contact.
